Subject: Permission for admission in Yenepoya Homoeopathic Medical College & Hospital, R.S. No.29, 30, 31, Naringana Village, Post-Deralakatte (Mangalore), Tah. Bantwal, Distt. Dakshin Kannada-575018, Karnataka with 100 seats in UG (BHMS) course for the academic session 2020-21-reg.

Sir,

I am directed to refer to the provisions prescribed under Section 12C of the Homoeopathy Central Council Act, 1973 and regulations made thereunder and Ministry's policy for the academic year 2020-21, In order to verify the compliance of availability of standards by the College, the Board of Governors to CCH has examined the Part-1 of the proforma of inspection of college submitted by the **Yenepoya Homoeopathic Medical College & Hospital** and furnished the recommendation as under:

"Recommended for allowing admission in I-BHMS Course for the session 2020-21 with the intake capacity of only 60 seats in existing UG (BHMS) course, due to insufficient eligible faculties.

The Committee also recommended to apprise the Ministry about ineligible teachers and that the college website is not updated. Details of ineligible teachers are as under:

a. *Dr. Aliwyn Anthony Pais (Prof. Pathology) Not considered eligible as discrepancy in the provided documents :-*

- *In the affidavit, date of joining as Professor in the present college — 01-04-2019.*
- *In the provided documents for the teacher's code date of joining as Professor in the present college — 27-02-2019.*
- *Previous college (Alva's H M College) claimed that he worked there till 31-03-2019.*

b. *Affidavit of Reader and Prof. of Practice of Medicine not provided."*

2. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, recommendations of the Board of Governors to CCH and observation of Hearing Committee, **conditional permission of the Central**

Government is hereby granted to Yenepoya Homoeopathic Medical College & Hospital, R.S. No.29, 30, 31, Naringana Village, Post-Deralakatte (Mangalore), Tah. Bantwal, Distt. Dakshin Kannada-575018, Karnataka for continuing admissions in 1- BHMS course during the academic year 2020-21 with intake capacity of 100 seats in UG (BHMS) course subject to availability of requisite number of fulltime teaching faculties, guest faculties and updated website before 31st December 2020.

3. It is further informed that 100% of the undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as all India quota for deemed University as they are all India in nature. The counselling for seats under all India quotas shall be conducted by the Central Government. If any seats are not filled up in the Central Counselling, the same shall be transferred to the concerned Deemed University to admit students as per rules / norms decided by Central Government. The permission of the college stands withdrawn if the college fails to comply with the central counselling for all India quota or the students admitted thereunder.

4. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under HCC Act & Regulations made thereunder. Discrepancies, if any, may be immediately brought to the notice of CCH and the Central Government.

5. The College shall comply with the provision for providing EPF and ESI facilities to the teaching, Non-teaching staff of the College/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

6. Further, the College shall submit comply with the procedure to get permanent registration of the Teachers,/ Hospital Clinical Staff/ Consultant in concerned State Boards/ Council where the college/ hospital is located or Central Registration of CCH by 31st December, 2020 as per the decision conveyed vide CCH's letter no. 15-1/2018-CCH(3)/18510-18768, dated 16th January, 2019 and decided by the High Court of Delhi in W.P. No. 2369 of 2019, which will be verified by the Council during next visitation while considering the matter for grant of permission for the A.Y. 2021-22.

7. The College has to comply with the full requirements of HCC (MSR) Regulations, 2013 by 31st December, 2020 for continuing admissions during the subsequent year. A copy of the compliance report shall be submitted by the college to CCH under intimation to this Ministry. Subsequently, CCH shall verify the compliance well in time for considering the admissions during the Academic Year 2021-22 and furnish the recommendation to the Central Government.
