Yenepoya Homoeopathic Medical College & Hospital, R.S No 29,30,31, Naringana Village, Post- Deralakatte, Ayush Campus Karnataka, Tah. Bantwal, Distt. Dakshina Kannada, Mangalore-575018, Karnataka with admission intake capacity of 100 seats for Undergraduate (BHMS) course for academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 29 and subsection (3) of the Act.

As per the observations made by MARB, following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below:-

A. Teaching faculty:-

- Total 28 fulltime faculty for UG are submitted in part -1. Few deficiencies observed are mentioned below:-
- a) There are no lower faculty available in Departments of Forensic Medicine and Anatomy
- b) There are no professor available in Department of Repertory as per requirement of all 3 faculties in 100 seats BHMS as per MSR 2013.

B. Hospital details:-

- Every IP/OP case shall be carefully recorded with clear diagnosis and follow-up.
- Copy of IPD case registers are not submitted in the part-1 for verification.
- Case records are not submitted against the direction issued from MARB. IPD and OPD case records (copy of one OP and one IP cases of 1st and last day of every month) shall be submitted for verification.
- Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number etc.

- Case sheets shall be maintained with complete case analysis and evaluation and repertorisation and made available in medical record room for academic purpose of students.
- Lab investigation report should be maintained properly in case records.
- All follow up attendance should be recorded on the case records.
- Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

All the shortfalls observed in your College shall be rectified within a period of 30 days or before counselling initiates, whichever earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be cancelled without further notice.

Considering the above observations, and facilities available, MARB has decided to issue Conditional Permission to Yenepoya Homoeopathic Medical College & Hospital, R.S No 29, 30, 31, Naringana Village, Post-Deralakatte, Ayush Campus Karnataka, Tah. Bantwal, Distt. Dakshina Kannada, Mangalore-575018, karnataka with admission intake capacity of 100 seats for Undergraduate (BHMS) course for academic year 2023- 24.

All admissions in Undergraduate / Post Graduate course shall be made from NEET qualified candidates only. It is further informed that, Counseling for all seats shall be done by the Central Government/ Ministry of Ayush.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
