Sub: Application for Letter of permission for functioning of Yenopaya Homoeopathic Medical college and hospital, R.S. No29,30,31, Naringana village, post-Deralkatte (Mangalore), Tah. Bantwal, Distt Dikshin Kannada-575018 with admission intake capacity of 100 seats for undergraduate (BHMS) for the Academic year 2024-2025 regarding.

Sir.

Yenopaya Homoeopathic Medical college and hospital, Naringana village, post-Deralkatte (Mangalore), Tah. Bantwal, Distt Dikshin Kannada is functional since 2018 has applied for sanction of UG (BHMS) course with 100 seats for the academic year 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

Board has received a letter File no :Y/REG/PA/YHMCH/GENL/2024 dated 23.05.2024 stating that the yenepoya(Deemed to be University) has decided in their academic council meeting to reduce the intake capacity of their BHMS program from 100 seats to 60 seats .It has requested the commission to consider the same and approve reduction in the intake capacity from 100 to 60 seats from the academic year 2024-25

Inspection of the college was conducted on 5/07/2024 and 6/7/2024. On careful examination of the application and inspection report, the Medical Assessment and Rating Board has observed the following shortfalls as per MSR requirements:

1. Teaching staff

Assistant professor is not available in Department of Repertory.

2. OPD and IPD Department

 OPD patient's details were mismatching with the OPD register and could not be verified Multiple medicines are prescribed to a patient at one time, in some case sheets. Most of the case taking sheets are incomplete. The name, Signature, time and date of prescriber is not found.

Demographic details of patients are not recorded on case sheets. Diagnosis and proper case taking is not done with no follow-ups of the patients. Case records shall be maintained with

detailed case history, complete case analysis, evaluation, repertorisation and justification of prescription made available in the medical record room for academic purposes of students and follow up attendance of patients.

3. College infrastructure and Departments

- Classrooms are not big enough to accommodate 100 students.
- The teaching plan and teaching diary are mismatching in depts.except Forensic Medicine dept.
- In Surgery department (Minor OT) Instruments are not properly maintained

Considering the above observations and facilities available, Medical Assessment and Rating Board has decided to issue Conditional Permission to Yenopaya Homoeopathic Medical college and hospital, R.S. No29,30,31, Naringana village, post-Deralkatte (Mangalore), Tah. Bantwal, Distt Dikshin Kannada-575018 for continuing UG/(BHMS) course with intake capacity of 60 seats (reduced from 100 seats) for the academic year 2024-25.

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

All admissions shall be made for NEET qualified candidates only. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college will be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.

If the College is aggrieved with the above decision, the College may place an appeal to the National Commission for Homoeopathy as per NCH Act 2020 section 24 sub-section (3) within a period of 30 days. Manual/instructions for the appeal are attached herewith
